## CENTRAL CHURCH

In consideration of receipt of voluntary services from the participants of the Men of Acts ministry sponsored by Central Church, I hereby release and agree to hold harmless and indemnify Central Church, its employees, classes, organizations, members, attendees, trustees, officers and agents from and against any and all liability, claims, demands, actions, damages, expenses and costs, including attorney's fees and loss of judgments of whatsoever kind and nature which may result from or arise out of services provided for me or for such services which may benefit me whether or not resulting in whole or in part from the negligence or from acts or omissions of either the participants in the Men of Acts of Central Church ministry and/or Central Church, its employees, classes, organizations, members, attendees, trustees, officers and agents.

### Men of Acts Guidelines

1. All requests for assistance must be submitted to Central Church, Attention Pastor Alan Humble.
2. Recipient of MOA assistance will supply needed materials. Upon special advance approval, additional material assistance may be available.
3. Recipient will have materials available on scheduled workday.
4. Recipient must be at home on the scheduled work date.
5. Requests of Central Church members and regular Attendees will take precedence before non-members.
6. All requested work should **not exceed 4 hours of labor**. If job is not completed on one workday, another request will need to be resubmitted for a later date.
7. MOA supplies labor. Recipient agrees to assist MOA by asking able-bodied residents of recipient's household to participate in the service project.
8. MOA will schedule all work for the predetermined "work day" each month.
9. Recipient must be able to meet with the Team Leader before scheduled work date for job assessment.
10. Recipient will need to agree with MOA Team Leaders' proposal for completing request.
11. Recipient may not request additional work on workday from what was originally approved.
12. Men of Acts will **not** preform the following duties:
  - Any work that Pastor Alan Humble or MOA Team Leader deems beyond MOA's abilities
  - Moving
  - Auto repair
  - Any work on **second floor** of home (roof repair, gutters, pressure wash, chimney repairs, and siding/fascia repairs)
  - Cosmetic work (painting non-damaged walls, wall papering, decorative landscaping, laying flooring)
  - Building of fences, decks, porches or other structures (excluding wheelchair ramps)
  - Cutting/Removing trees or tree branches that are larger than 3 inches in diameter. Removal of tree branches that are higher than 10 feet.
  - Any work that has already been completed by MOA in the past (no duplicate work)
  - Lifting or moving items that exceed 50 pounds
